Carol Cameron and her husband moved to Willamette View in 2011 after living all over the world – New York City, Kansas and Mexico City. She and her husband, Jim, who died in 2016, both worked for the former advertising powerhouse, Young & Rubicam. Carol is serving her fourth term on the board.

Elise Meyers moved to Willamette View in 2013 after spending years as the executive director for the Alzheimer's Association in Marin County, California. A native of Klamath Falls, Oregon, she says she always wanted to retire in Portland after she fell in love with the area as a student at Lewis and Clark College.

Her work for Alzheimer's patients showed her that health care costs can sometimes overwhelm family finances.

Ron Gustafson spent 32 years working for General Motors all over the world, as a computer programmer, systems analyst, business consultant, and systems developer. He retired to his native Oregon to care for his dad. They both moved into Willamette View in 2001 and became "terrific roommates." His father passed away a few years later, but Ron still lives in the community. It's this culture of family that has shaped his strong feelings to look out for residents who may need help.



A FINANCIAL LIFELINE WHEN YOU NEED IT THE MOST




OUR ASSETS GO WHERE DONORS INTENDED

Willamette View Foundation also supports residents who need help managing their day to day bills. We do this at no charge to the residents. The financial resources that allow us to do this have come from generous donors over the last five decades.



For many residents, a big part of the decision to move to Willamette View was knowing that Willamette View Foundation was available with resources to help them if their funds were ever exhausted. The Willamette View Foundation's Resident Assistance Program is like a Long-Term Care insurance policy, only there are no premiums for you to pay and it will pay all your care costs that your own resources cannot cover.
