The Willamette View Foundation's Mission is to help qualified residents of the Willamette View Retirement Community maintain their dignity and independence through assistance in satisfying their need for housing and financial security. Aid is provided through resident assistance and financial management programs, educational seminars, financial information services, publications, and grants to Willamette View, Inc. that benefit the community's residents.

Willamette View Foundation is a non-profit corporation separate and independent from Willamette View, Inc.

It was in September 2001, right before 9/11, that I began my relationship with Willamette View residents. Taking my first steps onto the campus, I felt the compassion and caring for others that speaks to the core of Willamette View residents. That culture is what has built the Willamette View Foundation reserves. Residents are the core of our mission.

When I started at Willamette View Foundation our net assets totaled almost \$10 million. Now our net assets total over \$22 million. During the past 20 years, we received \$10.8 million in contributions and bequests. Through 2015, the resident stores and other resident activities contributed \$1.1 million for our Resident Assistance Fund. We gave back to the Willamette View community with \$7 million in direct resident financial assistance, helped 86 residents manage tasks related to finances, and funded \$3 million in grants to Willamette View, Inc. for campus projects.

The growth of Willamette View Foundation and our ability to help residents is the result of the dedication and commitment of past and current residents; their belief in our mission and willingness to support each other. It's people caring for people. It's residents helping residents. It's support you can count on.

It is an honor to know and help residents. Being a part of the Willamette View community has been inspiring and rewarding. I look forward to serving the community for many more years to come.

Rosemary Quast has trekked the Swiss Alps, fished the rivers of eastern Montana, and worked as a school nurse in Alaska. At 100 years old, she has earned the right to offer this simple advice to new Willamette View Foundation board members: "Watch the investments. Keep tabs on the money."

Her advice is music to the ears of the Foundation's newest board member, **Greg Dufault**, a longtime investment advisor. Dufault wants to use his expertise to solidify funds to better withstand market fluctuations and be available forever.

"I know what financial security means to people," he says. "They don't want to worry. They don't want to think about money." Robert C. Moore – better known as R.C.A. – says that when he and his wife moved to Willamette View in 2011, the sense of financial security made possible by the Willamette View Foundation was central to their decision and he wants board members to know that.

"It's why we have peace of mind," he says. "If things go gunny-bag on me, my expenses will be covered, I've got a strong safety net."

Karron Cook – a Willamette View resident for five years -- echoes that sentiment. Her advice to our new board member?

"Just remember that residents are first in line and that we all need to know there's a backup plan if anything goes wrong."


FUND BALANCES 12/31/21

WE'LL EVEN MANAGE YOUR MONTHLY BILL PAY AT NO COST


